THE PEEK-A-BOO GIRL

The Field Gallery in West Tisbury is a simple geometrical structure of weather-beaten pine. But outside on a two-acre lawn Tom Maley has created a whimsical group of sculptured nymphs and goddesses and fauns. Here tourists have their pictures taken, weddings take place, and an occasional Shakespearean play is performed.

One Friday morning in late August, four people, entranced by this array of sculpture, were waiting for the gallery to open. At ten A.M. sharp, Fanny Bright, in charge of the gallery, got up from her desk and opened the doors. Ten minutes later the four came running at her with the news that *The Peek-a-Boo Girl*, a controversial work that had been touring the country, was slashed.

The four people were: Jose Gonza, a psychiatrist from Guatemala; Wendy Wurry, a patient under his care; Sydney Walstreet, owner of the Walstreet Gallery; and Jay Walker, an artist who

was showing at the Walstreet Gallery and not drawing much of a crowd.

Fanny called Sam immediately. It was routine procedure to search Fanny and the four visitors and then make a thorough search of the premises. When nothing turned up, Sam went about questioning his suspects. Jose said he'd walked into the main room from one of its two entrances and seen Walstreet and Walker standing in front of the painting and talking quietly. Wendy, still in a frenzy, gave Fanny a violent shove and elbowed her way past. "See!" she said, yanking open the drawer. "Look in here!"
